## PHOTOGRAPHY POLICY

ESTELLE MANOR is a place of *retreat*, connection and PRIVACY. To *protect* the experience of our members and guests, *photography* is thoughtfully LIMITED across the estate.

### PHOTOGRAPHY IS NOT PERMITTED IN:

- The Manor House
- All four restaurants
- The South Terrace and Pool
- The Clubhouse
- Eynsham Baths

These are *intimate*, PRIVATE spaces for our members and guests, so we ask that phones, cameras and FILMING devices (*e.g. smart glasses*) remain AWAY throughout these areas.

### PHOTOGRAPHY IS PERMITTED:

- Outdoors and across the grounds, including our Pursuits Paddocks and the Padel Courts, but *excluding* The South Terrace and Pool.
- During *private* events held in Fallow House, as long as it's not for commercial purposes.

We're ALWAYS happy for guests to CAPTURE the *beauty* of our setting in the bucolic countryside. However, to ensure everyone feels *comfortable* and respected, we ask that any PHOTOGRAPHY or *filming* in permitted areas is kept BRIEF and *discreet*. This *also* refers to VIDEO CALLS, which should be *limited* to PRIVATE spaces where your fellow members and guests will NOT be *impacted*.



## PHOTOGRAPHY POLICY

### PLEASE AVOID:

- Prolonged *filming* for long-form content
- Staged or styled *shoots*
- *Disrupting* other guests or the natural flow of the area
- Use of *professional* photography EQUIPMENT is *strictly* PROHIBITED, including outdoor areas

If in *doubt*, our team is always on hand to ADVISE. Thank you for helping us *preserve* the sense of ease, privacy and *belonging* that DEFINES time spent at ESTELLE MANOR.

### PROFESSIONAL, COMMERCIAL AND EXTENDED PHOTOGRAPHY

*Professional* or *commercial* PHOTOGRAPHY and filming of any kind is not *permitted* in any areas of the hotel or club, including OUTDOOR permitted areas. This is to *ensure* our members and guests are not *disturbed* or made to feel UNCOMFORTABLE at any point. Please contact the Estelle Manor MARKETING TEAM for any questions or enquiries.

### COMMERCIAL USE

We do not ALLOW filming or photography of *any* kind (professional or amateur) *anywhere* on the estate for commercial PURPOSES. This INCLUDES (but is not limited to): advertising, marketing, PR, content creation for commercial *benefit*, brand collaborations, paid social media and *promotional* activity.

### PRIVATE EVENT SPACES

Photography within *private event* spaces is PERMITTED for personal use or internal company use only. Commercial use is NOT permitted, INCLUDING (but not limited to) publishing *externally*, promotional use, or ANY use *connected* to marketing, PR or social media.
